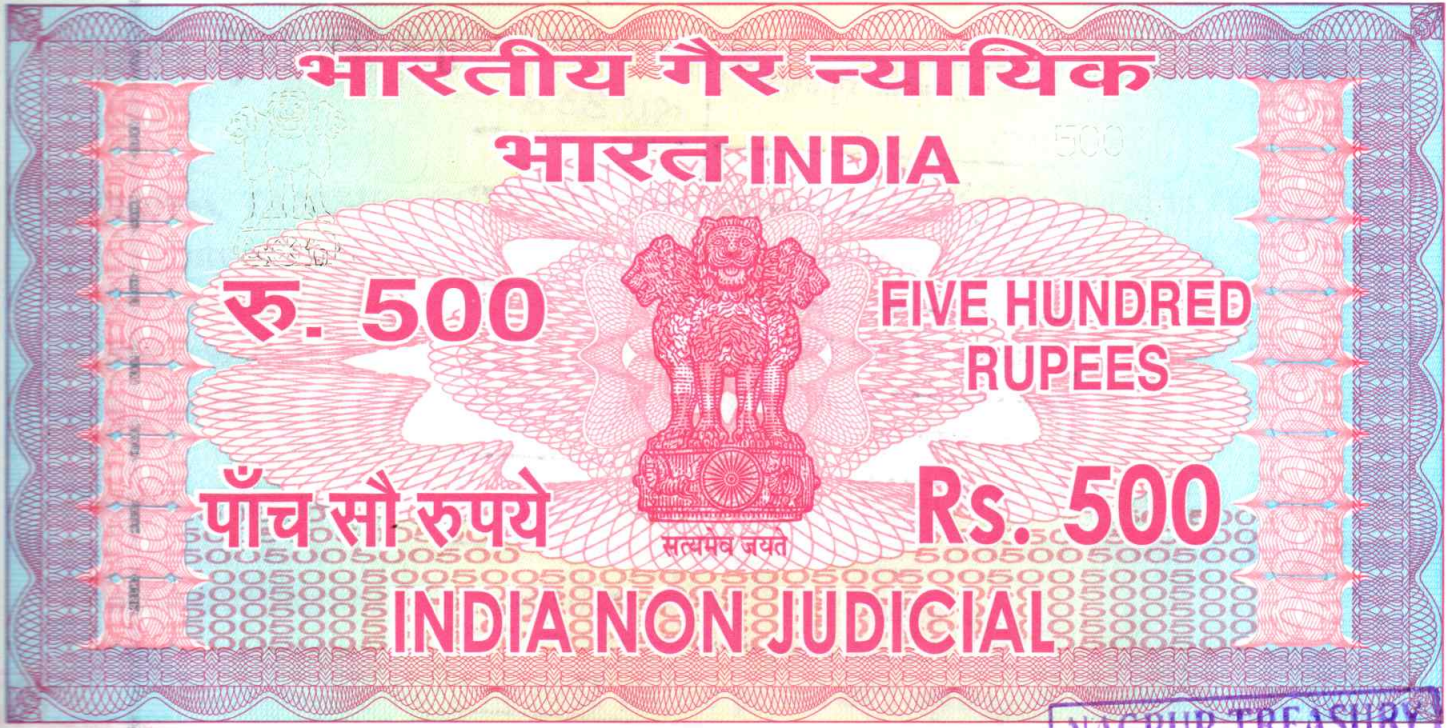

Whereas, **TANISHQ COLLEGE OF NURSING, Nagpur** affiliated to Maharashtra University of Health Science, Nasik, recognized by Indian Nursing Council, New Delhi and Maharashtra Nursing Council, Mumbai has asked for Clinical Training of its ANM, GNM and B.Sc Nursing and P.B.B.Sc., Nursing Students, including their university practical exam at **Kingsway Hospital, Nagpur** throughout their academic session.

Whereas **Kingsway Hospital, Nagpur** have expressed their consent and interest to permit for their clinical training including university practical exam at **Kingsway Hospital** throughout their academic session.

1. The agreement will be valid for the period of 1 (one) year from the date of this agreement to be renewed every year.

2. The nursing college will utilize the hospital faculty for clinical training of its students for around 5-6 months in each academic year.

3. The students will be posted in batch of 20 students for 4-6 weeks in each academic for 4-6 weeks in each academic year.

4. The students will have to abide by the code of conduct of the hospital.

5. No patient details are to be used for any other purpose other than academic use of students of the college.

6. The hospital reserves the right to discontinue any student and take disciplinary action as seemed fit for the action and misconduct performed during the course of training **Kingsway Hospital, Nagpur**.

7. The Clinical training in no way should harm any admitted patient or cause any discomfort of any nature to the patient.

8. The confidentiality of patients and patient's right to be adhered to during the course of students training.

9. The fees of training shall be Rs. 500/- (Rupees Five Hundred Only) per head (student) per month. Shri Mahavir Education Society shall deposit such fees with the Hospital sending such students for training.
